Emergency Information and Camp Responsibilities

Save this page for your camp visit.

- **Storm shelter is the Bath/Restrooms building.**
- **Review your process for a storm ahead of time.**
- **Weather radio is located in the kitchen.**
- **Defibrillator and basic first aid are located in the kitchen.**
- Pine Bluff Camp is not responsible for accidents or injuries.
- **Neighbors:** We enjoy excellent relationships with adjoining landowners and wish to keep it that way! Please stay within the camp for the safety and protection of all parties.
- **Caretaker:** Please respect the on-site Caretakers space and quiet time at night.
- **Flora and Fauna:** Please enjoy the wildlife – but do not disturb.
- **Fishing:** Follow Iowa fishing laws.
- **Swimming: No swimming is allowed at this time.**
- **Inner-Tubing:** The Upper Iowa River can be mighty, life jackets recommended while in the water.
- **Wifi & Phone:** Wifi is available at the shelter. A phone (with long distance) is located in the kitchen, the number is 563-382-5570.
- **Parking:** Park in the grassy parking area. Do not park in the lower area by the volleyball net.
- **Pets:** All Pets must be on a leash at all times. Campers must clean up after their pets.
- **Clean up:** We don't have cleaners so please leave things tidy. Dumpster is by the pole barn.
- **Buildings:** Please sweep, close windows, clean-up and turn off lights in buildings before departing.
- **Facilities:** See the website's [Facilities](#) page for more info
 - **Shelter:** The shelter is a covered area that is open on three sides with a fireplace. The kitchen is attached with a commercial stove, 2-door cooler, chest freezer, stainless steel sinks, and hot/cold running water.
 - **Cabins:** Four bunkhouse style cabins are available for overnight use. Three cabins accommodate 16 campers each and one cabin will accommodate 10 campers. Bunks and mattresses are provided but campers should bring their own pillow and sleeping bag or other bedding materials.
 - **Restrooms and Storm Shelter:** Restrooms are located near the cabins and have sinks, showers and hot and cold running water. Bring your own towels, soap etc. Restrooms are also the Storm Shelters.
